After the June rally, if you are heading to Maine, you might like to stop in at the annual **Maine Whoopie Pie Festival (**JUN 24, 2017) held in the town of Dover-Foxcroft.

What is a whoopie pie? Classically, it's two chocolate cake discs about the size and shape of the top half of a hamburger bun sandwiching a sweet, creamy white filling. Maine has named the whoopie pie the state's official snack, Various claims suggest that the whoopie pie originated in Massachusetts and spread both north and south, or that German immigrants in Pennsylvania brought the predecessor of the whoopie pie to communities throughout the northeast. A clue into how the possibly Amish dessert got to be so popular in New England can be found in a 1930s cookbook called *Yummy Book* by the Durkee Mower Company, the manufacturer of Marshmallow Fluff. In this New England cookbook, a recipe for "Amish Whoopie Pie" was featured using Marshmallow Fluff in the filling.

Chocolate Peppermint Whoopie Pies

Chocolate Peppermint Whoopie Pies have a refreshing peppermint-marshmallow cream filling, and are just the right size for small hands. Yield: About 20 whoopie pies Ingredients: 2c flour, ½ c cocoa powder, 1½ tsp baking soda; ½ tsp salt; ½ c vegetable shortening (or butter); 1 c granulated sugar; 1 c buttermilk; I large egg and 1 tsp vanilla extract

Instructions: Preheat the oven to 350 degrees and line two baking sheets with parchment. Set aside. In a medium bowl, sift together the flour, cocoa powder, baking soda, and salt. Set aside. In a large bowl, cream together the shortening and sugar. Add the egg and vanilla and mix until combined. Continue to mix on low speed while alternately adding the buttermilk and flour mixture. Stop to scrape the sides of the bowl with a rubber spatula as needed.

Spoon heaped tablespoons of batter roughly 3 inches apart onto the prepared baking sheets (a small cookie scoop works well here). Bake for 10 minutes or until the tops are puffed and a toothpick inserted into the center of one of the cakes comes out clean. Transfer to a wire rack to cool completely.

Filling ingredients: 1 cup vegetable shortening (or butter); 2 cups powdered sugar;2 cups Marshmallow Fluff and 1 tsp peppermint extract Instructions In a large bowl, blend together all of the ingredients until smooth. Spread the flat side of half the cakes with filling. Top with the remaining cakes to form a sandwich, then roll the sides in colored sprinkles, if you like. Wrap individually in plastic wrap until ready to serve.

Get Rid of Skunk Odor | Methods to Deskunk Your Dog

Tomato juice isn't the only (or best) old-time remedy to get rid of skunk odor from a dog. Keep these common household ingredients on hand and never live with the stink of skunk again!Everyone knows that tomato juice is handy for deskunking a dog, but it's not the only old-time remedy that works to get rid of skunk odor from your dog. Some other ingredients to keep on hand in quantity in case of emergency include vanilla extract, apple cider vinegar, and hydrogen peroxide.

Try dousing a skunked dog with about a cup of vanilla extract mixed in a gallon of water to get rid of skunk odor, says Hazel Christiansen, a longtime professional groomer and former president of the American Grooming Shop Association, in Lewiston, Idaho. Let the dog soak in the solution for about 10 minutes before applying dog shampoo and rinsing.

For the vinegar remedy, mix 2 parts water with 1 part apple cider vinegar, and set the solution solution. The quantities listed should make enough deskunking solution for a medium-size dog (30 to 50 pounds), so use less or more as needed for the size of your dog. aside (the total amount you'll need to mix depends on the size of your dog). Thoroughly wet your smelly dog's coat with water. Now, work the vinegar solution through the fur. Let the solution sit for about 5 minutes; then rinse thoroughly. Work carefully and be sure the solution doesn't drip into your dog's eyes (it would sting).

If neither of the concoctions above seems to work, here's one last skunk-odor removing remedy that's been passed on from one generation of dog lovers to the next. Mix 1 quart hydrogen peroxide, ¼ cup baking soda, and 1 teaspoon dish-washing liquid. Apply this mixture in the same way you would the vinegar.

The best way to eliminate skunk odor is to avoid it altogether. Believe it or not, skunks hate strong odors. You can keep them out of your woodshed or other outbuildings by hanging a bar of strong disinfectant or room deodorizer in the space.

CAR WINDOWS DON'T PROTECT AGAINST UV RAYS. Windshields generally block 96% of cancer-causing UVA rays. But side windows block only 71%, on average. This could increase drivers' risk for left-eye cataracts and cancer on the left side of the face. SELF-DEFENSE: Wear sunscreen whenever you drive..consider buying special window-tint products that block 99% of UVA rays. Study of ultraviolet protection provided by glass in 29 cars by researchers at Boxer Wacher Vision Institute, published in JAMA Ophthalmology.

More than 40% of sunscreens failed to live up to their sun-protection claims, according to a recent test. Among sun-screens that delivered their promised SPF, the two top-rated brands were La Roche-Posay Anthelios 60 Melt-in Sunscreen Milk SPF 60 and Trader Joe's Spray SPF 50+. Other sunscreens that met protection claims: Pure Sun Defense Disney SPF 50, Coppertone water Babies SPF 50, Equate Ultra Protection SPF50, No-Ad Sport 60, Ocean Potion Protect & Nourish SPF 30, Aveno Protect & Hydrate SPF 30, Banana Boat Sun Comfort Continuous Spray SPF 50, Neutrogena Beach Defense Water & Sun Protection SPF 70 (ConsumersReports.org)

Honey Remedy for Coughs!!

Sometimes you beat the flu, only to suffer from a lingering cough. A multiyear study of 100 people with a continuing cough reported that the following remedy was more effective than corticosteroids or cough syrups, according to a 2013 article in the *Primary Care Respiratory Journal*. Mix ½ teaspoon of instant coffee granules with 2½ teaspoons of honey. Stir into 7 ounces of warm water. Drink three times a day. Honey is a demulcent, meaning it coats your throat to soothe a cough, and caffeine dilates the bronchi in your lungs, which eases breathing. **Caution: For persistent coughs that last eight weeks or longer, check in with your doctor to rule out serious infections or causes, the Cleveland Clinic advises.**
