It has been a pleasure being your president for these past 5 years and I look forward to welcoming the new one as of the next election. Please step up as a candidate for one of these positions.


I hope to see you all in August, as well as next year at our rallies, and also at the Escapade to be held in Essex Junction, VT in July 2016.

Meeting Minutes

Note: Because a sufficient number of Chapter 3 members attended this rally, a chapter meeting was held on Wed., June 10th at 10:00am. Chapter officers present were: Joan Hurd, president; John DeRoy, V. Pres.; and Maureen DeRoy, treasurer. Ron Scopa substituted for, and recorded the meeting minutes for the Chapter secretary, who did not attend the rally.

With Joan presiding over the meeting, Maureen read her last report, stating that the current chapter roster included a total of 60 members. There were a few others who had not yet re-enrolled. The current chapter balance was \$1,007.63. Maureen also revealed that the registration forms and general itinerary for the August rally (LobsterFest) was ready to be included in the newsletter and also available to be added on the Chapter Webpage.

Joan reiterated the need for volunteers to oversee the key events scheduled during the August rally. Joan also talked briefly about the current Escapee special renewal fee (\$29.95/yr.) and the new Xscapers branch of the club. Joan also expressed the need of a new chapter officer nominating committee before the elections which is scheduled in August at the annual meeting. A new president will be needed because Joan will be stepping down, effective as of the conclusion of the annual meeting. As mentioned before in this newsletter, Mr. Hanson will be actively seeking suitable candidates for president and also secretary.

Hammond's Castle

Located in a quiet residential area in Gloucester, MA, adjacent to The Atlantic Ocean, lies a "medieval" castle home that was constructed in the late 1920's by John H. Hammond, scientist and inventor, whose creations were used by the military during World War II. One of his specialties was radio controlled ships and aircraft.

In 1914 he conducted radio guided experiments on a 44 foot boat that went on a guided 120 mile round-trip cruise

that immediately got the interest of the U.S. Navy. Years later, German spies stole one of his inventions, a design for an unmanned flying buzzbomb which led to the development of the infamous V-1 rocket plane/bomb that rained havoc on England during WW II.

The castle construction began in 1926, and as bridal present for Hammond's wife became their principal residence in 1929. While living there Hammond worked on many inventions and is credited with 437 patents. Later the castle became a museum, even while the Hammonds were still residing there.

Among Hammond's other inventions were the synchronization of motion pictures, television related inventions and a cosmic ray detector to name a few. Hammond's wife Irene was a famous portrait painter and a avid collector of Early American antiques.

Hammond spared no expense or detail in the construction and furnishings in the castle. In the Great Hall of the castle sits an enormous pipe organ that feeds several thousand organ pipes that lie hidden from view behind one of the hall facades. For those who may be interested in visiting the castle, it is situated off of MA Rte. 127, on Hesperus Ave. in Gloucester. *Note:* Henry W. Longfellow's poem about the "Wreck of the Hesperus" is based on a ship that was wrecked on the rocks of Norman's Woe that lies just offshore, very near the castle.
